CRESCENT POINT ENERGY TRUST CONFIRMS AUGUST 2004 DISTRIBUTION

Crescent Point Energy Trust confirms that the cash distribution to be paid on September 15, 2004 in respect of August 2004 production, for unitholders of record on August 31, 2004 will be \$0.17 per trust unit. The ex-distribution date is August 27, 2004.
